The Product is also consistent with the needs and objectives of consumers who require the flexibility of unlimited redraw, the ability to make additional repayments, and the ability to split loans.</p> <p><b>Description of likely objectives, financial situation and needs of consumers in the target market</b></p> <p>The Product has been assessed as meeting the <i>likely objectives, financial situation and needs</i> of consumers who:</p> <p><u>Likely objectives</u>: require a loan to purchase and construct an owner-occupied home with P&amp;I repayments or interest only repayments.</p> <p><u>Likely financial situation</u>: meet our eligibility criteria, including (but not limited to):</p> <ul style="list-style-type: none"><li>• are 18 years of age or older;</li><li>• have ongoing and stable employment; and</li><li>• can afford to make the required repayments.</li></ul>

<b>Restrictions on distribution</b>	This product should not be distributed to consumers who do not meet the credit requirements for this loan
<b>Review triggers</b>	<p>The events that may suggest that the TMD is no longer appropriate includes:</p> <ul style="list-style-type: none"> <li>• If the product details or terms and conditions change;</li> <li>• If the credit guidelines change;</li> <li>• if a significant dealing of the Product to consumers outside the target market occurs; or</li> <li>• if there are a significant number of complaints received from consumers in relation to the Product that reasonably suggests that the TMD is no longer appropriate.</li> </ul>
<b>Review periods</b>	The first review will occur 12 months after the introduction of this TMD, and this TMD will should be reviewed every 12 months thereafter.
<b>Distribution information reporting requirements</b>	<p>Distributors must provide the issuer with the following information:</p> <ul style="list-style-type: none"> <li>• the details of any complaint received, as well as the number of complaints received in every quarter ending on 31 December, 31 March, 30 June and 30 September; and</li> <li>• Any dealings in the Product which is not consistent with the TMD. This information must be provided as soon as practicable, and in any case within 10 business days after becoming aware.</li> </ul>
